Summer 2014

There have been many correspondence's and memorandums between myself and the GSO. I will do my best to cover them all one by one so you too can be as current as possible.

Letter from Phyllis H. General Manager for the General Service Office U.S./Canada: Letter dated January 2014

As an addendum to my message yesterday on the new <u>aa.org</u> Web site launch, I'm happy to

include the news that the mobile site is active and accessible on all smart phones and tablets with internet browser access. Please be aware there will be a different look as it is designed and written specifically for a mobile application. However, for tablets, you have the ability to switch to full Web site view on your device. Enjoy!

Correspondence between Publishing Director of AAWS, Inc. and myself on the 75 Anniversary Addition Big book:

Questions and Answers:

- How many copies have been ordered to date (we had 100,000 pre ordered in the beginning of April 2014, as reported at the GSC). We have printed 250,000 copies of the 75th Anniversary Commemorative Edition of *Alcoholics Anonymous*.
- 2) What is the exact cost or close approximation cost of each replica? The approximate unit cost (incorporating latest sales and invoices paid for paper, printing and binding) is \$3.54. This is \$1.10 greater than the original estimate of \$2.44, primarily due to much greater than expected cost of paper for this special edition. (The unit cost was never estimated at \$8.20; that was probably an estimated gross profit margin number that was quoted.)
- 3) Are there projections for the total number of Big Book replicas to be sold, again only asking for projections if you have them. No projection of total sales at this point, though I am expecting a rate of sale of approximately XXXXX copies a month through the balance of this year. (Note: I would appreciate it if you would <u>not</u> share my estimated monthly rate of sale publicly at this time.) We had sold 155,496 units at the end of May.

As you are aware from my last report I stated that I was asked to be an author of a proposal that I greatly believe in. This has taken a great deal of time from me and we will be presenting this proposal in a "Question and Answer " session in Perrysburg, Ohio at the ECR Conference.

Corrections Report – Jim McL.

Corrections Committee Report – Area 75 Summer Service Assembly, 2014

Volunteer Training

In this report I want to primarily address a number of Corrections volunteer issues we are currently experiencing. New regulations and volunteer policies are being implemented in both WI State Prisons and WI County Correctional Facilities. For State Prisons there will finally be a uniform process in place for registration and training of all volunteers. Now volunteers will need to go through a comprehensive training session every 2 years. Once you are approved and in the DOC computer for any State Prison you will not need to repeat the training to volunteer at another WI State Prison. Implementing a "standard" volunteer registration process and training program at all State Prisons will help us to understand and comply with the new policies.

There is one new change that will require us to modify how inside AA meetings are being conducted in State Prisons. The new volunteer policy states that <u>"Inmates are not allowed to lead programs or services for other inmates"</u>. This means that inmates are not permitted to chair AA meetings. AA volunteers must now take a more prominent role in leading inside AA meetings.

They also want us to maintain a more "professional relationship" with inmates. To establish "professional boundaries" we may no longer address inmates by their first names, instead referring to them as Mr. / Ms. and their **last name**. Inmates will be required to address us in the same way, so our last names will now appear on the volunteer ID badges we are required to wear.

A new federal regulation became effective for all federal, state and local corrections systems in 2012 called the Prison Rape Elimination Act, PREA. A presentation on this material is included as a component of the DOC standard training program for State Prison volunteers. No objections have been raised by AA volunteers who have completed this training in a classroom setting at a couple of different State Prisons.

Implementing the federal requirement of PREA training for volunteers in WI County Jails however has created some real problems for us. Unlike the State Prisons there is no administrative authority directing how and when individual County Jails will be introducing this program. There is no schedule available describing a timetable for implementation at specific County Correctional Facilities. We only know that some version of this training will likely be required for all volunteers in WI County Jails in the near future. To date we have learned that PREA training is now required for volunteers at the Racine and Waushara County Jails. Instead of including it as part of other on site volunteer registration and training activities these two counties have outsourced the training to a company named educorr. These counties are requiring that all volunteers complete the online training and testing program for PREA as provided by this company.

To meet this requirement AA volunteers will need to have access to a computer (and know how to use it) and will have to pay to register and use the online training program. In Racine the reported cost of educorr training is \$40. There is a test at the end of the program that must be passed in order to get a PREA Training Completion Certificate. I am hearing complaints that some AA members will not "pay to volunteer" and understand this reaction. This is a one-time training expense to use this online training program however that can't be avoided by volunteers.

At this time we don't know how this is going to roll out in other counties – how many will use this educorr program with its associated cost to volunteers to complete the required PREA training. We also don't know how quickly other counties will be moving to comply with this Federal regulation. What we need now is more information on what other counties are doing.

Other Corrections Activity

I participated in two major events since the last Service Assembly in April. At the Annual Area Conference last month in Racine I was on an Old Timers Panel at the end of the day on Saturday. This panel was very well attended and it was my privilege to share the microphone with a couple of local guys with a lot of years of sobriety. A few weeks ago I chaired the 38th Annual WI/UP Corrections Conference, this year hosted by Area 75 and held in Fond du Lac. The program included multiple panels, including 2 groups of recovered ex-offenders and another made up professionals working in Corrections. The featured speaker at the event was Clement C. from GSO who recently moved into the Corrections Chair.

 - 8. Talk to club houses regarding donation boxes for special needs, cd, tape players, etc.

[also received an email for District #13-Rick S who was looking for help in financing sign language interpreters as their state funding is running out They are looking for a group or groups, district or area to help out. Since the cost stated was over twice what our annual budget is for special needs-I needed to look at what GSO has to offer. What I found was a fountain of information to share with your groups, district and area-this can be found in the flyer-A.A Guidelines-Carrying the A.A. Message to the Deaf Alcoholic-in that particular flyer there is a wealth of information. I have printed up copies of that flyer and they are on the Back table-

Please take one or two back to share with your groups In the meantime I received an email that was forwarded to me in regards to the WICYPAA XXI 1 IN January 2015, also requesting info about finding a ASL interpreter . In 2008 the GSO Archives Committee requested that Areas submit their Archives history for the 2008 printing of the GSO Archives Workbook. In 2008 six Area Archives histories were printed in the GSO Archives Workbook. (Including Area 75)

The 2012 printing removed these six Area histories and replaced them with seven new Area Archives histories.

The fourth bulleted purpose in the GSO Archives Workbook states; "Serve as a resource and laboratory to stimulate and nourish learning."

The first page of the GSO Archives Workbook states; "This workbook is service material, reflecting A.A. experience shared at the General Service Office. A.A. workbooks are compiled from the practical experience of A.A. members in the various service areas."

We are not fulfilling the purpose of this workbook by removing these shared experiences.

What is your proposal?: Clarify the publication process for Area 75 Assembly Actions (see Attachment A)

How did this proposal originate?

At the Area 75 Spring Conference, the Agenda Committee discussed the ongoing problem of the Area 75 Assembly adopting documents as Assembly actions. While well intentioned, whenever the Area 75 Assembly adopts a document as an Assembly action, it prevents Area 75 Trusted Servants from updating that document in a timely fashion.

The Committee realized this had implications for the *Assembly Actions* document, a document that Area 75 Trusted Servants rely upon to understand the scope and framework of their service responsibilities. The Committee realized there were two pitfalls to avoid in publishing the *Assembly Actions* document. First, the Committee realized that adopting the *Assembly Actions* document itself as an Assembly action would prevent the document from being updated—and that this would have a devastating impact on the conduct of Area business. Secondly, the Committee realized that without some standards for publication, the document for meaningful guidance in the conduct of their service responsibilities.

The Agenda Committee then considered the standards involved, and reviewed the current update of our own *Assembly Actions* document and the A.A.W.S. Publication, *Advisory Actions of the General Service Conference of Alcoholics Anonymous*, 1951 – 2012 in devising the standards contained in the attachment to this proposal.

List any supporting documentation or background material attached to this proposal (if any):

Text of the October 21, 2012 Assembly Action pertaining to updates to the Assembly Actions document:

Once updates to Area 75 Assembly Actions or the Area 75 Handbook are approved they are to be posted to the area web site no later than 45 days following the assembly when adopted. Hard copies of the changed or added pages will be available to area committee members (area officers, area standing committee chairs and district committee members (DCM's)) who possess binders at the next scheduled area assembly that occurs at least 45 days following the assembly when adopted. The Alternate Chair will also furnish editable copies of the Area 75 Assembly Action and Area 75 Handbook to the Area Chair and the Area Secretary for backup purposes. This change will take place effective with the panel 63 rotation beginning January 2013. If adopted, this proposal will update the duties of the Area 75 Alternate Chair and the Area 75 Handbook.

List the primary benefits of your proposal to the area. What will happen if we adopt this proposal?

Area 75 Trusted Servants rely upon *Assembly Actions* to understand the scope and framework of their service responsibilities. Though the *Assembly Actions* document frequently refers to itself, there are no clear-cut standards for publishing this document. This proposal seeks to remedy this deficiency by providing clear standards for publishing the *Assembly Actions* document.

What will happen if this proposal is not adopted?

The *Assembly Actions* document will continue to exist as a matter of long-standing practice, without specific standards for its publication. Without these clear standards, the historical pattern of inconsistent standards in documenting Assembly actions is likely to continue, rendering the document less useful to the Assembly and to Area 75 Trusted Servants.

Estimate any costs to the area. Outline where funding would come from. Explain whether this is a one-time or ongoing expense.

This proposal is unlikely to incur any additional funding over and above what Area 75 currently authorizes for the printing of *Assembly Actions*.

1 Every formal action taken by the Area 75 Assembly should appear in *Assembly Actions* at least once. An action may appear multiple times in the document if the action pertains to more than one topic or subject. Each listing

in Assembly Actions shall contain the following information:

- a The verbatim text of the proposal that resulted in formal action
- b The date, location and the type of assembly at which the Area 75 Assembly took the action, and whether the action constituted emergency business.
- c Each Assembly action should be associated with a single, descriptive tag, used to identify the action in the *Assembly Action* table of contents, with the same tag used in each instance the action appears in the *Assembly Actions* document. The Alternate Chairperson shall attach such a descriptive tag to each action taken by the Area 75 Assembly and report all such tag designations to the Agenda Committee.
- 2 The standards established in this proposal, and any future changes to the publication standards for the *Assembly Actions* document, apply to updates of the document going forward from the date the Area 75 Assembly adopts such changes as a formal action. Where the listings for Assembly actions appearing in prior editions of *Assembly Actions* do not conform to any new standard, the Alternate Chairperson may rely upon the text and information for each entry contained in those prior editions of the *Assembly Actions* document unless and until a member of the Area 75 Assembly challenges that entry in *Assembly Actions*.
- 3 Any member of the Area 75 Assembly may challenge the text and related information for any Assembly action listed in *Assembly Actions*. The person challenging that entry is responsible for researching the Area 75 Archives for the original proposal that resulted in that Assembly action. Where there is a discrepancy between the original proposal and the text of *Assembly Actions*, the text of the original proposal shall prevail, and the Alternate Chairperson shall include the necessary revision in subsequent editions of *Assembly Actions*. Where no such information is available, prior editions of *Assembly Actions* should prevail, unless in the opinion of the Alternate Chairperson or the Agenda Committee the matter requires clarification by the full Area 75 Assembly. The Alternate Chairperson shall report all challenges and modifications to *Assembly Actions* to the Area 75 Assembly.
- 4 The Assembly Actions document should conform to the following standards:
 - a Each Assembly action should appear in every section of *Assembly Actions* where the category or topic of the section relates to that Assembly action.
 - b Within each section, the Assembly actions should appear in reverse-chronological order—the most recent Assembly action listed first and the oldest Assembly action last.
 - c *Assembly Actions* should contain a title page that includes full document title and the date of the update. Each page of the document should contain the short document title and the date of the document's update in the footer of the page.
- 5 The Alternate Chairperson, with the concurrence of the Agenda Committee and in conformity with all applicable Area 75 Assembly actions, A.A. Tradition, and *The A.A. Service Manual*, may without further Assembly action reorganize and reformat *Assembly Actions* to maximize its usefulness to the GSRs and to the DCMs, Area Officers and Committee Chairs.
- 6 The Alternate Chairperson can update the *Assembly Actions* document to include new Assembly actions and deliver copies of the updated document to the following Area 75 Trusted Servants within 30 days of any assembly where Area 75 takes any formal action.
 - a Full copies to the Area 75 Archivist and the Area 75 Webmaster
 - b Full, digitally editable copies to the Area 75 Chairperson and the Area 75 Secretary for backup purposes.
 - c A document containing only the changes to Assembly Actions to the Area 75 Secretary.
- 7 Updated copies of the *Assembly Actions* document can be distributed as follows:
 - a Within 15 days of receiving an updated copy of *Assembly Actions*, the Area 75 Secretary will distribute the document containing the changes to *Assembly Actions* to all persons on Area 75 Committee.
 - b Within 15 days of receiving an updated copy of *Assembly Actions*, the Area 75 Webmaster will post the updated version of *Assembly Actions* on the Area 75 Website.

What is your proposal?: Conference Checking Account Protocol Proposal: That the combined total of the conference checking account and the conference seed money shall not fall below \$12,500, of which a minimum of \$5,000 must be maintained as cash in the conference checking account as a conference reserve. Once the combined total of the conference checking account and the conference seed money exceeds \$13,500, then the excess over \$12,500 may be transferred to the general fund at the discretion of the Area 75 Treasurer in consultation with the Finance Committee.

How did this proposal originate?: The proposal originated from discussions with the Finance Committee, the Agenda Planning Committee, and the Conference Advisory Committee.

List any supporting documentation or background material attached to this proposal (if any).:

The conference checking account was established by assembly action in fall of 2013, with an initial balance of \$10,000. At the time the account was established, no formal guidance was issued as to when funds could be transferred back from the conference checking account to the general fund.

checking account and conference seed money will be established. It will also be clear when a transfer from the conference checking account to the general fund can be made by the Area 75 Treasurer.

What is your proposal?: Reestablish Service Material

- Classify the Area 75 Handbook and Area 75 Conference Guidelines as service documents.
- Except matters concerning Area 75 finances, each Area 75 Service Committee may create and revise their own service documents using suggested guidelines published in the *Area 75 Handbook*.

How did this proposal originate?

This proposal is based upon the "Service Publications Standards" proposal submitted to the Area 75 Assembly at the June 22, 2014 Summer Service Assembly. From the feedback received at the assembly, this alcoholic came to believe that a simpler version of the proposal might better serve the needs of the Area 75 Assembly. This draft is a suggested friendly amendment to the original proposal—it retains the ideas of the original proposal while simplifying the language and details.

List any supporting documentation or background material attached to this proposal (if any): The following quote comes from *The Twelve Concepts for World Service*, page 12 and 13:

[S]ome traditional and practical principle has to be devised which at all levels which at all levels *will continuously balance the right relation between ultimate authority and delegated responsibility*. How, then, are we going to accomplish this?

There are three possible attitudes that we might take toward such a state of affairs. We could, for instance, throw away all corporate charters, bylaws, job definitions, and the like. This would leave it entirely to each group of trusted servants to figure out what its authority and responsibility really is. But such an absence of any chartered structure would be absurd; nothing but anarchy could result.

Then of course we could take the opposite tack. Refusing to give our leadership any worthwhile discretion at all, we could add to our present Charters great numbers of rules, regulations, and bylaws that would attempt to cover every conceivable- action or contingency. That would be altogether too much red tape-more than we A.A's could stand.

The right A.A. solution for this problem is to be found, however, in the latter part of Tradition Two, which provides for "trusted servants." This really means that we ought to trust our responsible leaders to decide, within the understood framework of their duties, *how they will interpret and apply their own authority and responsibility to each particular problem or situation as it arises*. This sort of leadership discretion should be the essence of "*The Right of Decision*," and I am certain that we need not have the slightest fear of granting this indispensable privilege at nearly every level of world service. There will always be plenty of ultimate authority to correct inefficiency, ineffectiveness, or abuse.

If the Conference does not function well, the groups can send in better Delegates. If the Trustees get badly out of line, the Conference can censure them, or even reorganize them. If the Headquarters' services go sour, the Trustees can elect better directors and hire better help. These remedies are ample and direct. But for so long as our world services function reasonably well-and there should always be charity for occasional mistakes—then "trust" must be our watchword, otherwise we shall wind up leaderless.

List the primary benefits of your proposal to the area. What will happen if we adopt this proposal?

This proposal gives the Area 75 Assembly the chance to consider a different and perhaps better balance of delegated responsibility to Area 75 Trusted Servants.

What will happen if this proposal is not adopted?

The Area 75 Assembly would issue excessively detailed instructions to our Trusted servants (if the original proposal passes), or no direction at all (if the proposal fails.)

This proposal is unlikely to incur any additional funding from Area 75.


