It has been quite a journey since the beginning of the year. Keeping up with the electronic mail from GSO, the electronic mail from members of Area 75 and forwarding all I receive from GSO has been keeping me very busy. I hope all of you who are on my e-mail list see that I have been as transparent as I possibly can be. I have withheld no reports, memo's etc. My point is what I receive you too shall receive.

If anybody would like to be added to the e-mail list please look in the Area 75 Directory and e-mail me your address and you will be added. If you do not wish to be included in the communication chain please e-mail me with your request to be taken off the list.

There are three report's which I just received and have attached for those of you who are not on the e-mail list.

- **Corporate Board Report:** A.A. Grapevine Inc. Donald C. Chairperson
- **General Service Board Report**: Ward E. Chair of the General Service Board
- **Directors Report**: Alcoholics Anonymous World Service, Inc. Robert L. Chairperson A.A.W. S. These reports will be read as is at the 63rd General Service Conference.

There will be elections for the East Central Regional Trustee, Pam R. will be finishing her four year tem directly after the conference. I have been asked to invite our new trustee to the 2013, 2014 & 2015 Spring Conference, whom ever that may be. The nominations are as follows:

I have been blessed to be a part of this special vote and I can assure you that I have been asking all the candidates questions on their procedures if elected, especially about transparency with all documents coming to them (if possible) from the board minutes etc. This is an important issue to me. All nominee's have been asked by me personally if they will travel to Area Events when they are invited, this also is important. I have each of their resumes and can honestly say they are well qualified to be our trustee.

I will also be privileged to vote for the Trustee at Large/US this list will be reduce to one nominee. The nominee's are as follow:

There will be a total of 10 nominees'. The US will have 6 and Canada will have 4. The Delegates from each region will cast their vote and reduce the candidates down to one per region. The Delegates will then cast their final vote along with the trustees Committee on Nominating during

the Annual Meeting of the General Service Conference. At this point we will have a new Trustee at Large.

The delegate's workshop was a great success. We had an attendance of around 71 people, four of which were outside Area 75 (Current Delegate Area 20, Past Delegate Area 74, Member from Area 20 and Past East Central Regional Trustee). We were able to implement all thirteen committee's and the committee's were well attended by at least five or more members.

I have gone to great lengths to read and re-read the answers that each committee discussed. I will say that all of you who attended have my sincere appreciation of all the time and effort for coming here and participating the workshop. I have brought some copies of the Delegates Workshop Committee Agenda Summations. I will try to incorporate this report into the Delegates report so it to can go in the minutes. Incorporating the reports will not happen.

I would like to announce a workshop that should interest all members of Alcoholics Anonymous. The workshop titled "The Third Legacy" held at the Gratitude Club, 295 Ruggles Street, Fond Du Lac, WI. There will be flyers posted on the Area 75 Calendar and flyer's distributed to all clubs and districts. You will at minimum learn about the service structure of the AAWS and Grapevine Boards, Class A and Class B, Staff Members and etc.,. You will see and learn firsthand how this re-structuring (if it happens) will combine the boards, and how the structure will look after the restructuring.

GSO FINANCIAL RESULTS for 2012: Gross Profit from Literature \$7,878,000.00, Contributions were \$6,565,000.00, about 5% of all contributions are made on-line, totaling \$231,000.00. With a net profit of \$161,000.00.

Since December 9, 2011, 5,118 Big Books and 4,553 12 &12s in ebook format have been sold. In 2012- 1,738,857 book units have been sold. As you can see we are very dependent on literature sales, and nowhere near being fully self-supporting through our Groups voluntary contributions. Much work needs to be done here.

GRAPEVINE FINANCIAL RESULTS for 2012- Average Paid Circulation was 83,258, down from 2011, on-line circulation was 5,535, gross profit from sale of other publishing items was \$423,670.00. A total net profit of \$257,000.00

LAVINA FINANCIAL RESULTS for 2012- Average paid subscription was 9,157, up from 2011. Other publishing income, \$11,124.00, and a net loss of \$116,000.00

Unfortunately 2013 budgets do not look very good, GSO budgets a net loss of \$611,000.00. Some contributing factors, It costs over \$150,000.00 more to have the General Service Conference in Time Square this year as opposed to last year in Rye Brook. \$127,000.00 projected LaVina loss. Prepaid expenses for the 2015 International Convention. There will be expenses resulting with the site selection process for the 2025 International Convention. Increase in the contribution to the retirement plan, this will take up to three years to bring this status up to fully funded, per federal law. Upgrading aging computer equipment. And possible additional costs for Grapevine 12th Floor construction.

Grapevine budgets a profit of about \$12,000.00 and Lavina budgets a loss of about \$127,000.00. As of December 31, 2012 the Reserve Fund had a balance of \$15,353,752.00, and represents about 11.3 months of operating expenses.

There were three retirees this year from the General Service Office, Valerie O., Warren S, and Gayle S.R. And there are three new employees, Greg T., Clay R., and Steve

There were 1584 visitors to the General Service Office in 2012. There were 4,756,623 visits to GSO's AA web site in 2012.

Corrections Report – Jim McL.

Since taking over the position in mid-December through March 2013 I have processed 49 Prerelease Requests from inmates looking for AA contacts in the local community where they will be released.

District Corrections Chairs are the primary individuals I communicate with to find AA volunteers in their respective Districts to connect with inmates as outside contacts prior to their release. To date I have identified and have ongoing communication with individuals who perform this role in 21 of the 35 Districts in Area 75. In the instances where there is no specified Corrections Chair for a District I have contacted and forwarded requests to the DCM.

In February AA Corrections participated in the annual Transition Fair at the Oakhill Correctional Institution in Oregon, where I met both the OCI Warden and the Secretary of the DOC. This daylong event allows soon to be released inmates to meet with representatives of various community organizations as future contacts for jobs, social services, etc. I staffed a display booth where I passed out AA literature and Prerelease Contact forms. I also had the opportunity to talk with a number of inmates currently attending AA meetings in the facility.

Last month I attended the Tri-County Assembly in Kenosha. There were 2 Corrections Panels during this event that were led by Corrections Chairs Mark M. for District 7 and Dennis L. for

District 36. I also participated in the Delegates Workshop, leading the group that discussed proposed changes to some Corrections related literature. Later this month I have been invited to attend a District Meeting in Platteville to discuss the status of Corrections activity in District 9.

Special Needs as part of that group discussed and spoke about better ways to get out message out to the community and to help better serve them. Our District chairs have a lot of enthusiasm and good ideas. Special Needs will have a table available Friday night, May 17th, 2013 at the Area Conference to be available to the alcoholic in need. Also, Special Needs has been invited to set up a display in Fond du Lac, WI at the Gratitude Club for a workshop the 8th of June.
