<u>Corrections Report</u> – Jim McL.

There has been a lot of Corrections activity during the past few months. In April I attended the District Meeting in Platteville. Had the opportunity to meet the District 9 Corrections Chair and talk with a number of individuals who are AA volunteers at the multiple state and county correctional institutions in this large multi-county district.

During the month of May I participated in a Service Workshop in Kenosha, was on a panel presenting and discussing Corrections service opportunities. At the Area 75 Spring Conference a few weeks later I met with a number of District Corrections Chairs who were in attendance at this event and also delivered a Corrections Committee update report. Later on I attended a monthly meeting of the Milwaukee County Corrections Committee, MCCC, an ongoing effort to coordinate the activity of corrections volunteers from 8 districts bringing AA meetings to multiple Milwaukee County correctional institutions. This was a great opportunity for me to establish communication to better handle the Pre-release Contact Requests for inmates released to Milwaukee.

Earlier this month I attended the annual WI / UP Corrections Conference held this year in Appleton. I provided information on the status of corrections activity in Area 75. In addition I had the opportunity to meet and talk with the new Area 74 Corrections Chair. She will be a valuable contact to help coordinate Pre-release Contact Requests and other cross-area issues.

Last October I participated in a Re-entry Fair held at Oakhill Correctional Institution in Oregon. I was led to understand that these events are held annually at other minimum and medium security

institutions, usually in the fall. Jo Mc was able to provide me with the name of an individual at the Department of Corrections, when I contacted her she forwarded my inquiry to the Assistant Administrator for Division of Adult Institutions at the DOC. He has sent an expression of our interest in participating in these events and my contact information to all of the correctional institutions in the State. So far I have received an invitation from Kettle Moraine for a Re-entry Fair to be held on October 3rd. I know there will be Fairs also held at the Prairie du Chien, Taycheedah and Oakhill facility locations but have not received any information on their scheduling. I intend to work with the respective AA Outside Sponsors and local AA Volunteers if possible to staff our participation at these events.

PI Report – Jeanette S.

The PI Committee met with the CPC Committee at the Annual Conference on May 18 in Janesville. We had good discussion regarding the activities that Districts are doing: distributing meeting lists to: campgrounds, Chamber of Commerce, libraries, hospitals, tourists stops, churches, blood banks, family waiting rooms in medical offices, DA's office, and local bus and train stations. Since our last assembly meeting here in Madison there has been quite a flurry of activity. April 7th was our pre-conference assembly where Randy, our NY Delegate could get a sense of where our area was at and bring that info up to GSO. Later that month I was invited to be on a panel/workshop with other area chairs that was hosted by District 7/Kenosha. We were able to make report on our areas and inform people what is happening in our specific areas. It turned out to be an informational meeting and a sharing of information. Bob M, our past ECR Trustee, was also present and gave a PowerPoint presentation on our service structure. Since coming into this chair I have learned quite a bit, what exactly Special Needs includes also how as a part of a large whole we all work together to carry the message to the next alcoholic. Treatment Report - Kristi C.

Good afternoon everyone, thank-you for coming. My name is Kris C. and I am always going to be an alcoholic. Thank-you for the opportunity to serve as your Treatment Chair for this current rotation.

Since our last assembly meeting this April I have been busy getting to know more of you and attending various functions in the Area. In early May I attended the District 19 Workshop, Came to Believe, in Prairie du Sac. The Treatment Display was set-up with Bridging the Gap pamphlets available and my personal contact cards. There was an awesome line-up of speakers and panelists as well as a delicious lunch. I had a great time meeting new friends, talking about the Bridging the Gap program and sharing our experiences with service work in AA.

The following weekend I attended our Annual Service Assembly in Janesville-another awesome event. Randy's report was outstanding and with all the various topics that came up I was again reminded how much I don't know and how much there is yet to learn. We had a Treatment Committee meeting Saturday afternoon, attended by a handful of people. We exchanged some ideas of what is being done in some districts, what is working and what isn't. Ken Y mentioned a book that was used in the past, listing all the treatment facilities in WI. He followed up on that and found out the book is no longer being printed. He did get a contact number that we will use to try to get a hold of one of the last printings. I shared a dinner table with District 34 DCM Tony and Treatment Chair Patty and really enjoyed getting to know them better and hear about the work going on in their district.

June 1st I traveled to Appleton to attend the Area 74/75 Corrections Conference-just as a regular AA member-but I was interested to hear how others are Bridging the Gap in Corrections facilities. On June 8th I attended the 3 Legacies Workshop in Fond du Lac where I learned a bit more about the service structure of AA, shared my experience with treatment service work on one of the panels and heard an inspiring GSR/DCM presentation by Ken G and Sean M. Gavin has formed a Treatment subcommittee consisting of about ten people, serving four facilities. Nightly meetings are held in the Detox Center. In the next six months they hope to orientate six volunteers to be available for 12-Step calls for the Detox center at Mendota Mental Health facility where weekly meetings are now being held in both the minimum and medium security areas of that facility. Literature is being kept current at all locations. We talked about the various pamphlets that have been helpful in the line of Treatment service work as well as the Bridging the Gap program.

This July I plan on traveling to Appleton for the East Regional Conference and visiting the District 2 Service Workshop in August. In early September, I will be attending the National Bridging the Gap Conference in Schaumburg IL. I am really looking forward to this particular event and encourage all of you, especially those involved in Treatment or Corrections service work, to consider attending as well.

Grapevine Report – Nancy H.

Since my last report at the Pre-Conference Assembly in April I have brought the Grapevine display to Dist 7 workshop in Kenosha on 5/11; Area 75 Conference May 17-19 in Janesville; Dist 25 workshop in Fond du Lac on 6/8. I also spoke and brought GV materials to the Secretaries meeting at the Milwaukee Central Office on 6/11.

I met with the Literature committee at the Conference in Janesville. Good thing since no one came for the GV committee meeting. The committee meeting times and locations were not on the program which is something to remember in 2014 if we plan to hold committee meetings at the conference.

I passed a can for contributions to the Corrections Literature fund at the Conference collecting \$76.62 and when I spoke at the secretaries meeting at the Milwaukee Central Office collecting \$34.10. One use of the Corrections literature fund is to buy Grapevine subscriptions or other GV materials for prisons or jails. Does your group contribute??

Districts 12, 24, 25 and 36 were represented at the GV committee meeting today. Some of the items discussed involved what District GV Reps can do. Ideas included:

- Use the GV archives as a resource for meetings on the Traditions
- Recycle old GV's by taking to prisons and jails or leaving in Doctor or Hospital waiting rooms.
- Remind members that GV subscriptions cost only 8 cents a day and GV Complete (online & print) is only 13 cents. GV Complete saves you \$13.97 over subscribing separately to online and print versions.

The most recent issue of "Markings" available at aa.org included an article about the "A.A. Grapevine: A History of the International Journal of Alcoholics Anonymous". GV was first published in June 1944 and began as a local venture to be distributed to members in New York City. It became the national monthly journal by the second year of publication. Go to aa.org and find "Markings" to read more.

What is your proposal?:

Amend the existing financial reimbursement policy found in Appendix E, Attachment 5 of the Assembly Actions to allow for reimbursement of expenses incurred by the Area Corrections Chair when said chair attends the Wisconsin – Upper Peninsula Corrections Conference.

The revised section would read as follows with the items in *bold italic* being the new language added by this proposal:

Corrections Chair

 - a. Area 75 Assemblies
 - b. Delegate's workshop
 - c. District Meetings within Area 75
 - d. Workshops sponsored by Area 75 or an Area 75 District
 - e. Mini-conferences sponsored by Area 75 or an Area 75 District
 - f. Performing duties relevant to office as documented in the A.A. Service Manual, Twelve Concepts for World Service, Area 75 Assembly Actions or Area 75 Handbook.
 - g. Engaging in activities consistent with *Correctional Facilities Kit & Workbook, A.A Guidelines for Corrections Committees, A.A. Guidelines for Cooperating with Court, DWI and Similar Programs* or related A.A. service literature.

How did this proposal originate?:

Some have expressed a concern in the past that reimbursing the Correction Chair for attending the Corrections Conference was prohibited because the Conference was not hosted by Area 75 nor hosted by an Area 75 District.

Others feel that reimbursement is appropriate based on the general statement in the Financial Support of Area Officers that reads "Area Officers and Committee Chairs will be reimbursed for any reasonable expense incurred as a result of performing general service work that falls within the scope of their service position as defined in the A.A. Service Manual, Area 75 Assembly Actions, Area 75 Handbook or other A.A. service literature."

Once again this year, these discussions occurred and this proposal is being brought forth to settle the matter.
