Along these same lines, only in greater depth and detail, our Area 75 Archivist, Nancy S., has been researching and writing about AA in Southern Wisconsin and AA in general. You can go to the Archives link on our Area web site (area75.org) and find the piece titled Alcoholics Anonymous

History in Wisconsin. There are 9 new binders containing verifiable stories, dates, and pictures pertaining to pre A.A., the beginnings of AA, pioneers of A.A., and the beginning of AA in Wisconsin. Nancy finished the binders in time for the "AA Mini-Conference at the VA with Alanon participation" and the binders are now part of the traveling Archives display.

THE 8th ANNUAL AREA 75 ARCHIVES MOVIE DAY will be Sunday, October 27th at the Archives Room. Doors open at noon. The documentary of Bill Wilson will be shown at 12:30 followed by a raffle. If there are no flyers on the back table they can be found by going to the Archives tab on our Area website (area75.org) and the info is also posted on the area calendar. Come join us for food, drink, fun, and fellowship. Check out the Archives Room, your history, and the new binders.

The 2013 General Service Conference approved a commemorative 75th Anniversary Edition of the first edition, first printing of our book Alcoholics Anonymous. Mid-November is the start for preorders and books will be shipped to you in April 2014. Watch for the order forms in the Box 4-5-9 and the forms will also be prominently posted at www.aa.org. Nancy contacted Michelle Mirza at GSO archives; Nancy believed there must be some difference between the "exact replica" and an actual 1st edition, 1st printing, or someone could try to pass a replica off as the real deal. This was Michelle's reply: "On the inside copyright page there will be wording that reads commemorative 75th edition produced by AAWS or some similar language. This distinguishes it from any other ones that may be published."

From West Allis to Montello and from the VA to Reedsburg, the Archives display has been traveling. Of special note; the Milwaukee Tri-District Roundup (Districts 14, 16, and 27) was held in the lower level of Holy Assumption School. They utilized the whole Archives area, and I didn't have to travel or set up anything.

The Archives Room will be closed for the month of December but we still travel.

CPC Report – John H.

Since our last summer assembly I was able to attend events regularly. In July, the ECR Conference, which sparked yet another level of interest in our service.

In August, the 24th, District 2, Montello, I was part of a workshop, talking about the history of CPC and building solid referrals with professionals.

In September, IST on the agenda, the Serenity Club asked for participation with traditions. Tradition 9 and 10 were mine to elaborate on.

Then the 21st of September I was invited up to Lomira-District 21 at the Trinity United Methodist Church. My part was to put on a presentation and help answer questions. Not a lot of professionals showed up: not because of lack of effort-over 100 invitations were sent out to local professionals. We had a wonderful sharing session and I learned a lot.

On the 22nd and 23rd, District 19, Wisconsin Dells, the 32nd Annual WI Corrections Association. A first for our area, since this was for the professional that service the prisons. We had a nice exhibit set up for AA-a huge event and I had help from Jim, Area 75 Corrections Chair, Steve N. District 17 CPC Chair and Area 75 Special Needs Chair Tara H. We passed out lots of literature and shared our experience.

Oct 12, District 16 had a mini-conference at the VA hospital. I set up a display and shared info and met many more wonderful people.

<u>Corrections Report</u> – Jim McL.

We received around 50 Prerelease Contact requests during this last quarter. Soon to be released inmates fill out these forms and mail them back to the Area 75 PO Box. They are forwarded to me and I pass them on to the Corrections Chair in the District where they are going after release. District Corrections Chairs then find local volunteers to write back to the inmates and arrange to meet and take them to a local meeting when they get out. Most Districts have this process well organized at the local level.

There has been a lot of other Corrections activity during the past few months. At the Area 75 Spring Conference the end of June I delivered a Corrections Committee update report and also met with a number of District Corrections Chairs who were in attendance. In July I attended the East Central Regional Conference in Appleton. In addition to hearing a couple of great speakers I had the opportunity to meet and talk with a number of individuals who are involved in AA Corrections in other areas, especially Area 74 where the Conference was held.

During the month of August I participated in a District 2 Service Workshop in Montello. I was on a panel presenting and discussing Corrections service opportunities. In September I joined John H. in staffing an AA Information Booth at the annual conference of the Wisconsin Corrections Association. Our participation in this event was arranged by John, the CPC Chair.

Later in the month I attended a Corrections Workshop in Waukesha that was a combined effort of individuals from 3 Districts in Waukesha County. This was a great opportunity for me to establish additional Corrections contacts and improve communication to routinely handle the Pre-release Contact Requests for inmates released to Waukesha.

Earlier this month of October I participated in a Re-entry Fair held at Kettle Moraine Correctional Institution near Fond du Lac. Chris S. who is an Outside Sponsor for AA meetings held in this institution joined me staffing an AA Information Booth. We passed out AA literature and talked to a number of inmates at this event. Chris knew some of these guys so they were comfortable approaching our booth. These events are held annually at a number of minimum and medium security institutions, usually in the fall. We are scheduled to participate in similar events at the Taycheedah Women's Correctional Institution next week and at the Prairie du Chein Institution early in November. I have local AA Outside Sponsors lined up to participated with me to staff our booth at these two events.

Yesterday I enjoyed attending the District 19 Fall Workshop in Reedsburg. The speakers delivered a strong AA message on service and sponsorship and some great ribs were served for lunch. I got to meet and talk with the District 19 Corrections Chair, Mary Jo D. for the first time and with her help updated the contact information I have for AA meetings held at the Sauk and Richland County Jails.

Due to an unusually hectic summer, I was unable to attend several of the District workshops that I was invited to. My apologies to those Districts. I did attend the District 25 service workshop in Lomira on Sept 21st. They hosted the event to share information about AA to the professionals in their District. They shared information about the Area website and the many resources that are available on aa.org.

Special Needs Report - Tara H.

Since our last assembly meeting in June there have been many events that I have participated in and attended.

In July, as an attendee, I attended the ECR Conference and listened to the different speakers from GSO and our new trustee William F.-quite informative and good fellowship.

August 24th, I attended and participated in a workshop that was put on by District 2 in Montello. It was well attended by other chairs and we were asked to describe our chair positions and what we have found out about what are some of the projects or issues that the districts are dealing with. In District 2 it was having handicapped accessibility noted on meetings lists correctly for the different meeting places. Also what can we do to make our meeting places more accessible to the alcoholic in need and discussing the types of reconstruction that places would have to go through to make them handicapped accessible. The codes involved for the different municipalities, the cost and maybe sparking an interest in fellow AA's of the different meeting places and to get on board for such an undertaking, in the clubs. Several people stepped up and expressed an interest in forming a committee. I have a script that was passed on to me, I edited it and thought it might be a good idea to have copies made and passed around to the different meeting places, so people could be introduced to special needs and what we are able to provide if possible. Also a questionnaire that we can also leave at the different meeting places. There are copies on the table in the back if you are interested.

September $15^{\rm th}$ I was invited to the Serenity Club in Milwaukee for a workshop. My topic was to discuss traditions 7 & 8. This is to always remind me that we are always self-supporting through our own contributions and to remain non-professional in matters of carrying the AA message to the next alcoholic – both are spiritual principles which help keep us in check. Our traditions are valued principles which keep us together. The Serenity Club in Milwaukee hosts many AA events. I have been able to assist District 10 – Spanish speaking district at large – with translating equipment so other who do not understand Spanish can attend their functions and enjoy the message from the speakers. I was able to attend and help out John, our CPC chair, at the $32^{\rm nd}$ WI Correctional. It was quite a large event and there was a lot of interest for the booth he had set up for AA. Good morning – my name is Kris C and I will always be an alcoholic. The Big Book of AA tells me that nothing will so much insure impunity from drinking as intensive work with other alcoholics so I thank you for this opportunity to work with you as your Area 75 Treatment chairperson. I have

had an awesome summer and early autumn, a direct result of the time I've spent around the tables, picnic tables and the campfires of Alcoholics Anonymous.

Since our last assembly I have attended numerous AA events and learned something new or met someone new at every one. On July 19th I traveled to Appleton to the East Central Regional Conference. I left that conference with a better understanding of our service structure, our 12 concepts, and the importance of participation. On August 11th I was asked to give a short presentation on my position as Treatment chair at the Milwaukee Tri-County Round Up hosted by Districts 14, 16, & 27. Not sure about my presentation but our archivist Nancy gave a talk on local AA history which was incredibly enlightening. On August 24th I attended the District 2 service workshop in Montello where an amazing wealth of AA experience was shared. That afternoon I traveled to Prairie du Sac for the MAICO Reps picnic and heard some wonderful speakers share their stories.

The weekend of Sept 6-8th I attended the National Bridging the Gap Conference in Schaumburg, IL. I was astounded by how much I don't know! There is actually a Bridging the Gap website – btgww.org – to facilitate requests for contacts. I heard a panel, consisting of two judges who preside over drug courts, share their experience and I gained a new understanding and appreciation for the work they do. In my role as Literature Chair, I displayed the Literature Display at the Milwaukee Tridistrict workshop and the District Two Service Workshop.

I had the honor of speaking at the East Central Regional Conference, the Tri-district Workshop, the District 12 Annual Picnic and the District 30 mini-conference. In other news, the Fall 2013 Box 459 newsletter featured an article "Does Your Group Have a Literature Chair?" Copies of the article can be found on the back table.

News from A.A.W.S.

A.A.W.S. Online Store: The A.A.W.S. Online Store site for bulk orders has been implemented and operational as of May 8, 2013. In the first month that the sales Web site has been operational, they signed up 170 large purchaser accounts. The consumer online sales Web site is in progress with further testing scheduled for late-summer.

A.A.W.S. Use of Third-Party Vendors: Following the Conference Advisory Action regarding the distribution of A.A.W.S. ebooks through third-party vendors, the Publishing Department has initiated discussions with several distributors.

Commemorative First Edition Big Book: The Publishing department is moving forward with the editorial and production requirements of the facsimile edition of the first printing of the First Edition of the Big Book, to be published in April 2014. The A.A.W.S. Board approved the Publishing committee's recommendation that this 75th Anniversary Edition of the First Edition be priced at \$12.00.

50th Anniversary of *Les Alcooliques Anonymes*: At the request from multiple French-speaking area delegates for A.A.W.S. to produce an anniversary sticker to be added to the jacket cover of the French translation of the Big Book, A.A.W.S. approved the Publishing committee's recommendation that the requested sticker be produced to commemorate the 50th Anniversary of *Les Alcooliques Anonymes*.

International Licensing/Translations: There are 70 current Big Book translations, with 18 new translations pending. This year, to date, we have completed 14 translation reviews in seven languages; and completed 54 new licenses in four countries. We have also made further substantial progress on some of the ongoing Big Book translation projects, including Arabic, Navajo, Twi (Ghana) and Thai.

2015 International Convention Souvenir Book: The Board reviewed the concept of a Souvenir Book for the 2015 International Convention presented by the Publishing Director. Total gross sales for the first eight months through August 2013 are \$8,774,270, which is \$166,380 (1.93%) over estimate for the period, and ahead of last year's gross sales at this time by \$172,818. EBooks Unit Distribution: For the first six months of 2013, sales data through June 2013 reflect 1,248 Big Books and 1,167 Twelve Steps and Twelve Traditions in eBook format have been sold. At their September meeting, A.A.W.S. recommended that the price of e-book versions of A.A.W.S. literature be kept below their print version equivalents.

Also at their September meeting, A.A.W.S. recommended that a soft-cover, abridged, large-print edition of Alcoholics Anonymous be produced in early 2014.

News from Trustees' Committee on Literature

Development of literature focused on spirituality: Taking into consideration discussion at the 2013 General Service Conference, the committee continued its discussion on the development of literature which focuses on spirituality. They agreed to forward to the Publishing Department suggestions on size, content and format and requested that a draft pamphlet or progress report be brought to their November 2013 meeting. EBooks Unit Distribution: For the first six months of 2013, sales data through June 2013 reflect 1,248 Big Books and 1,167 Twelve Steps and Twelve Traditions in eBook format have been sold.

"Circles of Love and Service": The committee reviewed the 2013 Conference Committee on Literature suggestions for the draft pamphlet "Circles of Love and Service" and agreed to forward the suggestions to the Publishing Department requesting that a revised draft be brought to their November 2013 meeting.

"Questions and Answers on Sponsorship": The committee briefly discussed the many suggested changes to the pamphlet "Questions and Answers on Sponsorship." Due to the scope of these suggestions, the chair appointed a subcommittee consisting of Christine H., chairperson, Carole B., Joe D., Teresa F., a member of the Publishing staff and the committee secretary.

"Twelve Concepts for World Service Illustrated": The committee reviewed a suggestion to change the last sentence of the first paragraph of the text on Concept XII in the pamphlet "Twelve Concepts for World Service Illustrated" and recommended that the current sentence which reads: ". . . like the Twelve Steps and the Twelve Traditions—be changed only by 'written consent of three-quarters of all A.A. groups in the world!" Be changed to: ". . . like the Twelve Steps and the Twelve Traditions—be changed only by 'written consent of three-quarters of the repsonding A.A. groups in the world."

Conference Advisory Report - Nancy G.

The Area 75 Conference Advisory Committee met three times since the last Assembly; on July 7, July 28 and September 28. Those meetings yielded revisions to the Conference Advisory Committee Guidelines and the Area 75 Conference Guidelines, as well as a proposal to change the timing of the annual Area 75 Conference from Spring to Fall.

The Conference Advisory Committee Guidelines are deemed service material by Assembly action and thus the revisions to that document require no formal approval by the Assembly. However, copies are available for those interested. The Area 75 Conference Guidelines document is subject to approval by the Assembly. However, based on the possibility of adoption of the proposal changing the conference to the Fall, we are postponing submission of the guidelines document revision to the Assembly. If the proposal passes, the guidelines will again be revised to reflect that change and subsequently submitted to the Assembly for approval.

The proposed change from Spring to Fall suggests that the transition year be 2016, and that in that year, two conference will be held; i.e. the one currently scheduled in Oconomowoc and one in the Fall yet to be bid. The time needed to secure a hotel contract in order to facilitate that second

conference in 2016 will be limited. Because of that we are asking that the proposal for the conference timing change be submitted to the Assembly as new business today, and to then be considered for a vote at the Winter Service Assembly in January. This will allow an additional 3 months to finalize the hotel negotiations.

The Committee is also working on a Conference Bid Kit for use by the districts wishing to host a conference, along with several other ongoing topics.

It is proposed:

That the Area 75 Conference, currently held annually in May (or June) of each year, be held in October or November (preferably the third weekend of October) of each year; and,

That the transition year be 2016; and that, in that year, two Area Conferences be held; i.e., the one already scheduled for May In Oconomowoc and the first newly proposed one in October or November; and,

That a one-day Spring Service Assembly be held to facilitate Area business previously conducted at the annual Conference held in the Spring, including but not limited to, the Area Delegate's report on the annual meeting of the General Service Conference and Area 75 Standing Committee meetings.

Benefits of the Proposal

The proposal would:

Eliminate the problem of the delegate sometimes having less than a week to prepare a report following the annual meeting of the General Service Conference.

- Allow us to schedule the Delegate's report with more flexibility when not tied to the Area Conference.
- Allow for more flexibility in booking a facility for the Conference weekend when not dealing with scheduling conflicts such as the dates of the General Service Conference, Mother's Day, Memorial Day, and graduations. Also, we will no longer be challenged by increased facility summer room rates.

- Provide that the Regional Trustee may be more likely to attend our Conference due to its separation from the dates of the General Service Conference. Also, in the case of a newly elected Trustee, (s)he would have attended a General Service Board meeting prior to a Conference held in the Fall.
- Allow more time during the Conference to complete business normally scheduled at the Fall Assembly; e.g. Standing Committees would meet during the Conference weekend. Currently at the Fall Service Assembly there is no time for the committees to meet.

Background

Based on the findings of a 2007 Area 75 ad hoc committee, a proposal was passed to eliminate the Area 75 Fall Conference in favor of one Area Conference to be held annually in the Spring. The suggestion of holding the annual Conference in the Spring versus the Fall was made pursuant to preferences indicated by a majority of the Districts via questionnaires and District visits.

Influenced by subsequent questioning and input from the Fellowship, and by declining Conference attendance, the Area Conference Advisory Committee has discussed in depth the feasibility of moving the annual Conference from the Spring to the Fall. After thorough consideration, the Committee believes this to be a very worthwhile suggestion.

Estimated Funding Required

For the transition year 2016, additional funding will be required. The expenses budgeted for the Area Officers and Standing Committee Chairs to attend the Area Conference will be increased due to two conferences in that year.
