Literature Price Increase beginning October 1, 2014

On July 3, 2014 Bill N, AAWS Board Chair, and Phyllis H, General Manager GSO, announced a literature price increase that will be effective October 1, 2014. The rationale given in their letter was "Our last price increase was on July 1, 2009, five years ago. We have had several reviews since then and were able to delay any action until now."

On August 4, 2014 another letter was received from Bill N and Phyllis H with further explanation of the price increase; "As you know, literature prices help to cover costs for services provided by the General Service Office. As we strive to become more self-supporting it is necessary for the Board to raise prices to maintain the level and quality of those services and the financial health and stability of the office." The new pricing schedule for October 2014 has been released and every piece of our literature has been increased, some by as much as 20%. If you include the price increase from 2009 the combined increase can be as high as 39% on certain pieces of our literature with the highest increases being applied to our "Big Book", "12x12", and "Daily Reflections"; our largest seller to those of us doing 12 step work.

In the August 4th letter there was an announcement that shipping on orders up to \$50 would remain the same (\$10), but those orders of \$51 - \$500 would be lowered by a slight 4%. Orders over \$500 would continue to be shipped at no charge to the purchaser, with the costs being absorbed from the profits of the literature.

With the profits from the sale of the 75th Anniversary Edition (cost to produce is about \$3.54 vs cost of the book being \$12.00, net profit of \$8.46) and the increase of all literature sales that traditionally occur before a price increase goes into effect, the amount of unbudgeted excess revenue should be quite substantial at the end of 2014. If we sell one million Big Books (average over last five years) in 2015, the profit from those sales alone could be an <u>additional</u> \$1.5 million. Questions that should be asked are; what is the stated purpose for this additional profit and where will this money be used to help the alcoholic who still suffers?

After considering the budget presentation given to the Delegates at the GSC the question that comes to mind is; does it seem that our Office is in need of financial stability and help in maintaining the level and quality of services that a literature price increase of this scale is warranted? The GSB Treasurer very clearly pointed out that the Groups have increased contributions to the highest levels in history in 2012 and 2013. For the last two years there has been "excess revenue over expenses" or what we might call profit, even though losses were budgeted for each year. The pension liability fund is in great shape, as is the Reserve Fund even to the point that an extra \$1.5 million could be applied to the Pension Asset fund from the Reserve Fund. In the closing remarks of the Treasurer's report to the GSC in May of **2014** cited no financial problems were on the horizon.

At the end of 2013 our fellowship contributions were the highest in history to the GSB surpassing \$6.9 million. By the way this surpassed the previous highest amount which was set in 2012 of over \$6.5 million. Percentage of Groups contributing continues to decline reaching an all-time low of 42.5%. Area 75 group's that continue to donate have decreased from 27.53% in 2013 to 26.59% in 2014 ending on June 30th, 2014.

In reviewing the financial statements as they were presented in the General Service Conference reports 2005 thru 2014 and the General Service Board Treasurer's presentation at the 64th General Service Conference I have arrived at the following conclusion. Over the last nine years Alcoholics Anonymous has made a profit (excess revenue over expenses) every year except for one for a sum total of \$5.9 million dollars and the GSB has budgeted for a profit of \$295,000 in 2014. Our Prudent Reserve has risen from 8.8 months in 2005 to 10.9 months in 2013. Contributions since 2005 have been steadily increasing by about 27%, with total revenue up about 24%. It appears to me like our Fellowship has been providing the funding "to continue provision of vitally needed services and maintenance of our Reserve Fund" and that a price increase was not warranted this October? Since 2005 we have been responding as our cofounder Bill W. once said that the Fellowship will respond if the need is expressed. In the closing remarks of the GSB Treasurer's report to the GSC in May of 2015, he cited no financial problems were on the horizon.

Tradition 7: "... principle that AA must always stay poor. Bare running expenses plus a prudent reserve would henceforth be the Foundation's financial policy. . . . At that moment, we believe, the principle of corporate poverty was firmly and finally embedded in AA tradition."

Concept XII Warranty Two; "Sufficient operating funds, plus an ample Reserve, should be its prudent financial principle."

Corrections Report – Jim McL.

Corrections Activity

October is a busy month for Reentry Fairs in the WI State Prisons. These scheduled events give us an opportunity to pass out AA literature and talk with hundreds of inmates who will be released into local communities in the near future. We have the opportunity to connect them with local AA contacts or meeting locations in the area of the state where they will soon be living. I participated in three such events this month at the Kettle Moraine, Prairie du Chein and Jackson-Black River Falls Correctional Institutions, accompanied by a local AA volunteer in each instance. I will be attending the last of these events scheduled this year on Thursday at the Taycheedah Women's Prison near Plymouth.

Volunteer Training

New regulations and volunteer policies are being implemented in both WI State Prisons and WI County Correctional Facilities. For State Prisons there is a uniform process in place for registration and training of all volunteers. Both current and new volunteers need to go through a comprehensive training session

every 2 years. Once you are approved and in the DOC computer for any State Prison you will not need to repeat the training to volunteer at another WI State Prison. Having a "standard" volunteer registration process and training program at all State Prisons is helping us to understand and comply with the new policies.

DOC has provided a list of scheduled trainings in Adult Correctional Institutions for the remaining months of 2014 as follows:

10/22	5:00 PM	Milwaukee Women's Correctional Center
11/29	1:00 PM	Racine Correctional Institution
12/02	5:30 PM	Oregon Correctional Institution

Later this year they will send us an updated schedule of trainings / locations that will be offered in 2015.

There is no training schedule available for County Correctional Facilities. Unlike the State Prisons there is no central administrative authority directing how and when individual County Jails will be introducing their training programs. We only know that some version of the federal PREA training will likely be required for all volunteers in WI County Jails in the near future. Implementing this training for volunteers attending AA meetings at the Racine and Waushara County Jails has been difficult. Instead of including it as part of other on site volunteer registration and training activities these two counties have outsourced the training to a company named educorr. These counties are requiring that all volunteers complete the online training and testing program for PREA as provided by this company.

We don't know how quickly other counties will be moving to comply with this Federal regulation. What we need now is more information on what other counties are doing about volunteer training.

You may also register online.

The preregistration fee is \$100 USD; after May 12, 2015, registration will be \$110.00 USD. Your registration badge entitles you to attend all Convention events, including the Thursday night Party in the Park, the Stadium meetings on Friday, Saturday, and Sunday in the Georgia Dome, and all of the marathons, panels, workshops, and topic, special interest and other meetings at the Georgia World Congress Center and nearby hotels.

Housing reservation information, including the Housing Bureau's contact information, will be included with your registration confirmation. Similar to the 2010 Convention, housing for the 2015 International Convention is on a first-come, first-served basis. However, you must be registered for the Convention before you can make your reservations. Once your registration form and payment have been received, you will receive housing information by the same method you sent in your registration. If online, a link to the Housing Reservation website will be sent to your email address along with your registration confirmation. You will then be able to complete your hotel reservation online.

If you register by mail or fax, housing information will be sent to you by postal mail. Complete your housing and deposit information and send it to the address indicated on the Housing Reservation Form. Your hotel reservation will be processed and a confirmation mailed to you.

As at other International Conventions, many A.A.s will be accompanied by Al-Anons and Alateens (check appropriate badge box on form), and Al-Anon and Alateen have scheduled a variety of daytime activities, including meetings and workshops at the Marriott Marquis. Over the next few months, our entire catalog of A.W.W.S. titles will be offered as e-Books through the major third-party vendors for the various platforms and e-reading devices and in the three languages of our General Service Conference.

Publishing

For the first seven months of the year, through July 2014, total gross sales were \$9,320,076 -- \$356,335 (2.4%) over estimate for the year to date. For the sales month of July, we saw \$1,172,740 in actual gross sales vs. the \$1,092,300 estimate -- \$80,440 over budget (7.4%) for the month.

Sales in GSO's two Online Stores (bulk orders and direct-to-consumer sales) accounted for 53.23% of all sales in the month of July. For the year to date, web orders total \$4,655,015, or 51.5% of total sales.

The fall 2014 edition of *Box 4-5-9* has been distributed in English and French, with Spanish to follow shortly. The current issue features a front-page story on the 70th anniversary of Alcoholics Anonymous in Quebec, Canada. Also, a special trilingual publication, titled "A Brief History of the Big Book" (F-166) was mailed with the fall issue. This booklet covers, in digest form, the history of the first English, Spanish and French editions of Alcoholics Anonymous, recounting the stories of the publication of our basic text in each language.

Literature Price Increase Shipping and Handling Charge Decrease

Effective October 1, 2014

As you may be aware, it is the policy of A.A. World Services, Inc. to review literature prices every three years for any price adjustments that may be needed. The last price increase was on July 1, 2009, five years ago. On February 3, 2014, the General Service Board accepted the A.A.W.S. Board's recommendation for an increase in literature prices.

Effective October 1, 2014, most book prices in the three languages of our Conference (English, Spanish and French) will be increased. You will find the new price list for books below.

As you know, literature income helps to cover costs for services provided by the General Service Office. As we strive to become more self-supporting, it is necessary for the Board to raise prices to maintain the level and quality of those services and the financial health and stability of the office.

The A.A.W.S. Board has decreased the shipping and handling charges at the same time the literature price adjustment goes into effect, October 1, 2014. You will find the new schedule of those rates on the below.

Emergency Business

This emergency proposal passed with a 84 to 2 vote.

Proposal Sponsor(s) and Sponsor's Service Position (if any): Incoming Area 75 D-18 DCM Mike DeB., Past A75 D36 DCM Jim DeB. and Past A75 D36 DCM Don G.

What is your proposal? Introduce as emergency business the motion to rescind the Area 75 Assembly Action of September 14, 1997 that dissolved District 18 (Adams County) and incorporated Adams County into District 02.

List any supporting documentation or background material attached to this proposal (if any): The text of the September 14, 1997 Area 75 Assembly Action that dissolved District 18 and incorporated Adams County into District 02.

"It is proposed that District 18 be dissolved and that the portion of Adams County formerly covered by District 18 be considered part of District 02".

How did this proposal originate? Over 8 months ago the GSR's of Adams County chose to remove themselves from District 02 and work to bring more localized representation back to the Adams County A.A. Groups. This process began on June 29, 2014 at an organizational meeting held at the Adams-Friendship Alano Club. There was great support for this action and the second meeting was held on August 9, 2014. Officers were elected and future committee meetings have been set to establish District Committees such as: Corrections, CPC/PI and Literature.

List the primary benefits of your proposal to the area. What will happen if we adopt this proposal? Travel time for the Adams County A.A. Groups to attend their district meeting would be greatly minimized. The focus of the A.A. members would be on their own needs and those of the still suffering alcoholics in their county.

Enthusiasm will gain momentum and the message of Alcoholic Anonymous and General Service would spread quickly within Adams County.

What will happen if this proposal is not adopted? The GSR's of Adams County will experience undue stress while trying to "Carry the A.A. Message" to the still suffering alcoholics in Adams County.

Estimate any costs to the area. Outline where funding would come from. Explain whether this is a one-time or ongoing expense. District 18 is creating their own district fund to support the ongoing activities of their DCM and other District 18 Committee Members. No cost to the area.

What is your proposal?: Reestablish Service Material

- Classify the Area 75 Handbook and Area 75 Conference Guidelines as service documents.
- Except matters concerning Area 75 finances, each Area 75 Service Committee may create and revise their own service documents using suggested guidelines published in the *Area 75 Handbook*.

How did this proposal originate?

This proposal is based upon the "Service Publications Standards" proposal submitted to the Area 75 Assembly at the June 22, 2014 Summer Service Assembly. From the feedback received at the assembly, this alcoholic came to believe that a simpler version of the proposal might better serve the needs of the Area 75 Assembly. This draft is a suggested friendly amendment to the original proposal—it retains the ideas of the original proposal while simplifying the language and details.

List any supporting documentation or background material attached to this proposal (if any): The following quote comes from *The Twelve Concepts for World Service*, page 12 and 13:

[S]ome traditional and practical principle has to be devised which at all levels which at all levels will continuously balance the right relation between ultimate authority and delegated responsibility. How, then, are we going to accomplish this?

There are three possible attitudes that we might take toward such a state of affairs. We could, for instance, throw away all corporate charters, bylaws, job definitions, and the like. This would leave it entirely to each group of trusted servants to figure out what its authority and responsibility really is. But such an absence of any chartered structure would be absurd; nothing but anarchy could result.

Then of course we could take the opposite tack. Refusing to give our leadership any worthwhile discretion at all, we could add to our present Charters great numbers of rules, regulations, and bylaws that would attempt to cover every conceivable action or contingency. That would be altogether too much red tape-more than we A.A's could stand.

The right A.A. solution for this problem is to be found, however, in the latter part of Tradition Two, which provides for "trusted servants." This really means that we ought to trust our responsible leaders to decide, within the understood framework of their duties, how they will interpret and apply their own authority and responsibility to each particular problem or situation as it arises. This sort of leadership discretion should be the essence of "The Right of Decision," and I am certain that we need not have the slightest fear of granting this indispensable privilege at nearly every level of world service. There will always be plenty of ultimate authority to correct inefficiency, ineffectiveness, or abuse.

If the Conference does not function well, the groups can send in better Delegates. If the Trustees get badly out of line, the Conference can censure them, or even reorganize them. If the Headquarters' services go sour, the Trustees can elect better directors and hire better help. These remedies are ample and direct. But for so long as our world services function reasonably well-and there should always be charity for occasional mistakes—then "trust" must be our watchword, otherwise we shall wind up leaderless.

List the primary benefits of your proposal to the area. What will happen if we adopt this proposal?

This proposal gives the Area 75 Assembly the chance to consider a different and perhaps better balance of delegated responsibility to Area 75 Trusted Servants.

What will happen if this proposal is not adopted?

The Area 75 Assembly would issue excessively detailed instructions to our Trusted servants (if the original proposal passes), or no direction at all (if the proposal fails.)

Estimate any costs to the area. Outline where funding would come from. Explain whether this is a one-time or ongoing expense.

This proposal is unlikely to incur any additional funding from Area 75.

Sponsor's Service Position: Agenda Planning Committee, DCM Member

What is your proposal?: Clarify the publication process for Area 75 Assembly Actions (see Attachment A)

How did this proposal originate?

At the Area 75 Spring Conference, the Agenda Committee discussed the ongoing problem of the Area 75 Assembly adopting documents as Assembly actions. While well intentioned, whenever the Area 75 Assembly adopts a document as an Assembly action, it prevents Area 75 Trusted Servants from updating that document in a timely fashion.

The Committee realized this had implications for the *Assembly Actions* document, a document that Area 75 Trusted Servants rely upon to understand the scope and framework of their service responsibilities. The Committee realized there were two pitfalls to avoid in publishing the *Assembly Actions* document. First, the Committee realized that adopting the *Assembly Actions* document itself as an Assembly action would prevent the document from being updated—and that this would have a devastating impact on the conduct of Area business. Secondly, the Committee realized that without some standards for publication, the document would be useless to the members of the Area Committee—that they would be unable to rely upon the document for meaningful guidance in the conduct of their service responsibilities.

The Agenda Committee then considered the standards involved, and reviewed the current update of our own *Assembly Actions* document and the A.A.W.S. Publication, *Advisory Actions of the General Service Conference of Alcoholics Anonymous*, 1951 - 2012 in devising the standards contained in the attachment to this proposal.

List any supporting documentation or background material attached to this proposal (if any):

Text of the October 21, 2012 Assembly Action pertaining to updates to the Assembly Actions document:

Once updates to Area 75 Assembly Actions or the Area 75 Handbook are approved they are to be posted to the area web site no later than 45 days following the assembly when adopted. Hard copies of the changed or added pages will be available to area committee members (area officers, area standing committee chairs and district committee members (DCM's)) who possess binders at the next scheduled area assembly that occurs at least 45 days following the assembly when adopted. The Alternate Chair will also furnish editable copies of the Area 75 Assembly Action and Area 75 Handbook to the Area Chair and the Area Secretary for backup purposes. This change will take place effective with the panel 63 rotation beginning January 2013. If adopted, this proposal will update the duties of the Area 75 Alternate Chair and the Area 75 Handbook.

List the primary benefits of your proposal to the area. What will happen if we adopt this proposal?

Area 75 Trusted Servants rely upon *Assembly Actions* to understand the scope and framework of their service responsibilities. Though the *Assembly Actions* document frequently refers to itself, there are no clear-cut standards for publishing this document. This proposal seeks to remedy this deficiency by providing clear standards for publishing the *Assembly Actions* document.

What will happen if this proposal is not adopted?

The *Assembly Actions* document will continue to exist as a matter of long-standing practice, without specific standards for its publication. Without these clear standards, the historical pattern of inconsistent standards in documenting Assembly actions is likely to continue, rendering the document less useful to the Assembly and to Area 75 Trusted Servants.

Estimate any costs to the area. Outline where funding would come from. Explain whether this is a one-time or ongoing expense.

This proposal is unlikely to incur any additional funding over and above what Area 75 currently authorizes for the printing of *Assembly Actions*.

- 1. Every formal action taken by the Area 75 Assembly should appear in *Assembly Actions* at least once. An action may appear multiple times in the document if the action pertains to more than one topic or subject. Each listing in *Assembly Actions* shall contain the following information:
 - a. The verbatim text of the proposal that resulted in formal action
 - b. The date, location and the type of assembly at which the Area 75 Assembly took the action, and whether the action constituted emergency business.
 - c. Each Assembly action should be associated with a single, descriptive tag, used to identify the action in the *Assembly Action* table of contents, with the same tag used in each instance the action appears in the *Assembly Actions* document. The Alternate Chairperson shall attach such a descriptive tag to each action taken by the Area 75 Assembly and report all such tag designations to the Agenda Committee.
- 2. The standards established in this proposal, and any future changes to the publication standards for the Assembly Actions document, apply to updates of the document going forward from the date the Area 75 Assembly adopts such changes as a formal action. Where the listings for Assembly actions appearing in prior editions of Assembly Actions do not conform to any new standard, the Alternate Chairperson may rely upon the text and information for each entry contained in those prior editions of the Assembly Actions document unless and until a member of the Area 75 Assembly challenges that entry in Assembly Actions.
- 3. Any member of the Area 75 Assembly may challenge the text and related information for any Assembly action listed in *Assembly Actions*. The person challenging that entry is responsible for researching the Area 75 Archives for the original proposal that resulted in that Assembly action. Where there is a discrepancy between the original proposal and the text of *Assembly Actions*, the text of the original proposal shall prevail, and the Alternate Chairperson shall include the necessary revision in subsequent editions of *Assembly Actions*. Where no such information is available, prior editions of *Assembly Actions* should prevail, unless in the opinion of the Alternate Chairperson or the Agenda Committee the matter requires clarification by the full Area 75 Assembly. The Alternate Chairperson shall report all challenges and modifications to *Assembly Actions* to the Area 75 Assembly.
- 4. The Assembly Actions document should conform to the following standards:
 - a. Each Assembly action should appear in every section of *Assembly Actions* where the category or topic of the section relates to that Assembly action.
 - b. Within each section, the Assembly actions should appear in reverse-chronological order—the most recent Assembly action listed first and the oldest Assembly action last.

- c. Assembly Actions should contain a title page that includes full document title and the date of the update. Each page of the document should contain the short document title and the date of the document's update in the footer of the page.
- 5. The Alternate Chairperson, with the concurrence of the Agenda Committee and in conformity with all applicable Area 75 Assembly actions, A.A. Tradition, and *The A.A. Service Manual*, may without further Assembly action reorganize and reformat *Assembly Actions* to maximize its usefulness to the GSRs and to the DCMs, Area Officers and Committee Chairs.
- 6. The Alternate Chairperson can update the *Assembly Actions* document to include new Assembly actions and deliver copies of the updated document to the following Area 75 Trusted Servants within 30 days of any assembly where Area 75 takes any formal action.
 - a. Full copies to the Area 75 Archivist and the Area 75 Webmaster
 - b. Full, digitally editable copies to the Area 75 Chairperson and the Area 75 Secretary for backup purposes.
 - c. A document containing only the changes to *Assembly Actions* to the Area 75 Secretary.
- 7. Updated copies of the Assembly Actions document can be distributed as follows:
 - a. Within 15 days of receiving an updated copy of *Assembly Actions*, the Area 75 Secretary will distribute the document containing the changes to *Assembly Actions* to all persons on Area 75 Committee.
 - b. Within 15 days of receiving an updated copy of *Assembly Actions*, the Area 75 Webmaster will post the updated version of *Assembly Actions* on the Area 75 Website.

Once the combined total of the conference checking account and the conference seed money exceeds \$13,500, then the excess over \$12,500 may be transferred to the general fund at the discretion of the Area 75 Treasurer in consultation with the Finance Committee.

How did this proposal originate?: The proposal originated from discussions with the Finance Committee, the Agenda Planning Committee, and the Conference Advisory Committee.

List any supporting documentation or background material attached to this proposal (if any).:

The conference checking account was established by assembly action in fall of 2013, with an initial balance of \$10,000. At the time the account was established, no formal guidance was issued as to when funds could be transferred back from the conference checking account to the general fund.

List the primary benefits of your proposal to the area. What will happen if we adopt this proposal? If this proposal is adopted, then a minimum allowable balance for the conference checking account and conference seed money will be established. It will also be clear when a transfer from the conference checking account to the general fund can be made by the Area 75 Treasurer.

What will happen if this proposal is not adopted? If the proposal is not adopted, then the Area 75 Treasurer will have to bring future requests to transfer funds from the conference checking account to the general fund as emergency business to the Area Assembly.

Estimate any costs to the area. Outline where funding would come from. Explain whether this is a one-time or ongoing expense. There would be no cost to the Area.
